**PROGRAM GUIDELINES**

The Kentwood Housing Commission Paint Program is a program designed to provide low and moderate-income residents the opportunity to purchase exterior paint for their homes. The cost to the homeowner is set at \$5.00 (\$3.00 for seniors) per gallon, with the Kentwood Housing Commission paying for the balance of the cost of the paint. Homeowners must make arrangements to provide all labor and other materials (brushes, rollers, ladders, etc.) to paint their homes. All work should be completed in a good workmanlike manner. Eligible applicants must reside in Kentwood and be the owner-occupants of the property to be painted. Proof of home ownership, homeowner’s insurance and income must be provided to the Kentwood Housing Commission. The Kentwood Housing Commission shall monitor the program to assure that the project has been properly completed.

Paint will be available at Seven’s Paint & Wallpaper Company at 3070 – 29<sup>th</sup> Street SE; Kentwood, Michigan. Prior to picking up paint, applicants must be pre-approved by the Kentwood Housing Commission and issued a voucher. The voucher will allow the applicant to purchase paint at Seven’s Paint & Wallpaper. The \$5.00 or \$3.00 per gallon charge will be paid at the Kentwood Treasurer’s Office. The Kentwood Planning Department will then issue the voucher. Seven’s Paint & Wallpaper will then bill the City of Kentwood for the cost of the paint.

**CERTIFICATION OF APPLICANT**

The applicant certifies that all of the information in this application and all information issued in support of this application is given for the purpose of obtaining home repair assistance and is true and complete to the best of the applicant’s knowledge and belief. The applicant further certifies that he/she is the owner of the property described in this application and that the assistance will be used only for the materials necessary to complete the paint project for the subject property. The applicant further understands that he/she is responsible to assure that the paint is utilized for painting of the subject property; any unused cans of paint must be returned or purchased at full price. Neither the Housing Commission nor the City of Kentwood shall be held responsible for any damage or injury to persons or property resulting from the use of paint purchased through the Kentwood Paint Program.
